3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Logistics team leader are:

Core task 1: Coordinates and assists in the receipt and storage of goods

- 1.1 Coordinates receipt and storage of goods
- 1.2 Supervises colleagues by receipt and storage of goods
- 1.3 Unloads goods
- 1.4 Inspects received goods
- 1.5 Makes goods ready for storage and stores them

Core task 2: Coordinates and assists in the assembly and preparation for transport of goods

- 2.1 Coordinates the assembly of goods and making these ready for delivery
- 2.2 Supervises colleagues by assembly of goods and making these ready for delivery
- 2.3 Assembles goods
- 2.4 Carries out treatments on products (VAS activities)
- 2.5 Makes goods ready for delivery
- 2.6 Loads goods

Core task 3: Coordinates and assists in keeping an inventory of the stock

- 3.1 Coordinates the stock inventory
- 3.2 Supervises the colleagues by the inventory of the stock
- 3.3 Makes an inventory of the stock
- 3.4 Enters new goods into the system

Core task 4: Supports the input of people and methods

- 4.1 Discusses the logistics process with the manager
- 4.2 Makes a suggestion about the arrangement of the team
- 4.3 Supervises the development of the colleagues
- 4.4 Is responsible for the maintenance of machines and materials

He can do the senior secondary vocational education programme for Logistics supervisor.</p>	<p>International agreements The profession of Logistics team leader is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
